The Federal Motor Carrier Safety Administration's CSA 2010 (Comprehensive Safety Analysis 2010) is a national safety initiative to more effectively identify and quickly intervene with large truck and bus drivers and carriers who are not complying with safety rules in order to make the roads safer for everyone. Comprehensive Safety Analysis 2010, CSA 2010, is a new, high-impact Federal Motor Carrier Safety Administration (FMCSA) safety program to improve large truck and bus safety and ultimately reduce crashes. It introduces a new enforcement and compliance model that allows FMCSA and its state partners to contact a larger number of carriers earlier in order to address safety problems before crashes occur. When the program is fully rolled out by the end of 2010, we will have a new nationwide system that will make the roads safer for motor carriers and the public alike!
